

#### What is Cyber Bullying

A form of harassment or bullying inflicted through the use of electronic or communication devices such as computer, mobile phone, laptop, etc.

- Low self-esteem
- Suicidal ideation
- · Feelings of isolation, fear, anger and anxiety
- Leads to physical symptoms such as tension headaches,
   insomnia, and even more severe conditions like panic attacks
- . School/College absenteeism and drop out





#### What is Cyber Stalking

Cyber stalking is a type of cybercrime that uses the internet and technology to harass or stalk a person.

- Cyber stalking sometimes escalates to offline stalking that can lead to physical harm
- The fear of being stalked can trigger the body's "fight or flight" response leading to increased heart rate, elevated blood pressure
- Change in behavior such as experiencing social phobia
- · Fear of entering new relationships
- Trust issues with current relationships





#### What is Morphing

Morphing is altering or changing the pictures of the person using morphing tools available online.

- Damage to reputation both personally and professionally
- Leads to emotional Distress including anxiety,
   embarrassment, and feelings of violation
- Victims experience identity crisis
- Can lead to physical symptoms such as tension headaches, insomnia etc
- Increases the risk of Self- Harm





#### What is Cyber Fraud

Crime committed on internet with the intent to corrupt another individual's personal and financial information stored online

- Financial losses
- . Identity theft
- Emotional distress
- Trust issues
- Damage to reputation
- Legal consequences






#### Other Common Cyber Incidents

- Online harassment: Repeatedly sending offensive messages via email or other text messaging to a person.
- Exclusion: Cruelly excluding someone from an online group
- Sexting: It is an act of sending sexually explicit digital images,
   videos, text messages or emails usually by phone.
- Impersonation/Identity theft: It is an act of fraudulently or dishonestly making use of the electronic signature, password or any other unique identification feature of any other person.

#### Promotion and Prevention of Cyber Bullying

- Recognize the signs of cyberbullying, like receiving abusive messages, exclusion from online groups, or the spread of hurtful content
- Take screenshot of your conversation as evidence.
- Always check the authenticity of the person before you accept friend request
- Think Before You Share any information on social media
- Avoid retaliating or engaging with the bully
- If the online environment is becoming overwhelming, take breaks from social media
- Share your experience with trusted adults
- · Report abuse like spam, harassment to the concerned authorities
- · Always keep your all social media accounts private



#### Promotion and prevention of Cyber Stalking

- Never share your correct/accurate details like name, address, phone number etc. to strangers online
- · Always share your trip to your trust one while travelling alone in cabs
- Don't advertise your location/hangouts anywhere that you are away from home
- · Be careful while sharing information on vlogs
- · Never meet a stranger alone, whom you know online

#### Promotion and prevention of Cyber Morphing

- · Never share your pictures to strangers on any social media platform
- · Never auto-connect to open Wi-Fi networks in public places
- Never share your mobile devices with strangers
- Always use strong PIN code for your mobile devices which is tough to predict
- · Keep your social media accounts private/locked



#### Promotion and prevention of Cyber Fraud

- Never share your account number, bank details with people online
- Never open or download e-mail attachments from strangers
- Keep your passwords strong, the stronger your password, the more secure is your information
- Always use Licensed OS, Antivirus with Security
- Always use secured websites that start with https://
- · Be careful while doing online shopping
- Always close other applications while doing online transactions
- Never send sensitive details like credit/debit card number or passwords through e-mails or on phone
- Use different passwords for different accounts and change them regularly
- Beware of Jobs scams/ Money Scams/ Lottery frauds
- Check your bank statements on regular basis and if you found any unauthorized transaction report to concerned authorities
- Do not download mobile apps from any unauthentic source or through the links received on e-mail
- Check the text messages from your banks regularly to detect any unwanted digital/financial frauds



#### Addressing Health Issues of cyber Related Incidents

Ensure to communicate with trusted adults/friends:

It Lightens up your mind, provide guidance and make others aware about the incident



Practicing mindfulness: Practice mindfulness to avoid mind wavering and increase one's ability to relax and manage stress

An online survey commissioned by Symantec Corporation has found that 80% of adult inclian internet users have suffered some form of online harassment. The security software company's antivirus business

Norton conducted

the survey in India in the months of May & June this year. Here are some of its findings:





Most common forms of harassment:
Abuse and lesuits

59% Malicious gossip and rumours

4596 Threats of physical violence





. . .

- 65% of those under the age of 40 reported harassment
- In 40% incidences of cyberbullying and 50% cases of cyberstalking, the perpetrator was a stranger
- 71% people with disabilities reported receiving threats of physical violence

## Laws on Cyber Incidents In India under IPC & IT ACT 2005

- Sec.66A Sending offensive messages through communication service, etc.
- Sec.66C Identity Theft
- Sec.66D Cheating by personation by using the computer resource
- Sec.66E Violation of privacy
- Sec.67B Punishment for publishing or transmitting of material depicting children in any sexually explicit act, etc. in electronic form
- Sec. 65- Tampering with computer source documents
- · Sec. 67- Publishing information which is obscene in electronic form
- · Sec. 68- Failure/refusal to comply with orders
- Sec. 69 Failure/refusal to decrypt data
- · Sec. 70- Securing access or attempting to secure access to a protected system
- Sec.72 Breach of confidentiality and privacy
- Sec.503 Indian Penal Code (IPC) Sending threatening messages through email
- Sec. 506 IPC-Punishment for criminal intimidation. If threat be to cause death or grievous hurt, etc
- Sec. 507 IPC- Criminal Intimidation by an anonymous communication
- Sec.509 IPC Word, gesture or act intended to insult the modesty of a woman
- Sec,499 IPC Sending defamatory messages through email
- Sec .500 IPC Email Abuse
- Sec. 354 A IPC-Sexual harassment and punishment for sexual harassment.
- Sec. 354 D IPC Stalking
